



Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.casaofdreamscdc.org and CASA of DREAMS CDC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to CASA of DREAMS CDC include www.casaofdreamscdc.org. The CASA of DREAMS CDC website is a 501c3 Nonprofit Organization site. By using the CASA of DREAMS CDC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, CASA of DREAMS CDC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title

If you purchase CASA of DREAMS CDC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

CASA of DREAMS CDC may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Household Income

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

CASA of DREAMS CDC collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Sharing Information with Third Parties

CASA of DREAMS CDC does not sell, rent or lease its customer lists to third parties.

CASA of DREAMS CDC may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Tracking User Behavior

Automatically Collected Information

- SSL Protocol

When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.

Right to Deletion

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
